 - To be able to provide psychiatric services to those students identified as having mental health needs. We require a Child Psychiatrist to provide these services to students enrolled at the Eastern NC School f/t Deaf.
- 4. How does the contract add value to the teaching/learning process?
 - Having a Child Psychiatrist to provide for the mental health needs of students will ensure availability of care and enhance the student's educational experience.

 - Neither ENCSD nor GMS have a Child Psychiatrist on staff. In order to provide needed mental health services to our students, we require the services of this contract.

 - The services will not be provided without contracting. If the services are not
 provided the students needing these services will not be able to access the
 care.

 - The cost for ENCSD is based on services not to exceed Three Hundred Thirty (330) hours annually at a cost of \$130.00 per hour. We are also reimbursing travel not to exceed 2320 miles at Fifty-three and 1/5 cent (\$0.535) per mile, based on the state allowable rate determined by the IRS. Total mileage reimbursement not to exceed \$1,241.20. The mileage rate is subject to change. Allowable mileage is from the contractors work site or home site, whichever route is closest.
 - The cost for GMS is based on services not to exceed Three Hundred Thirty (330) hours annually at a cost of \$130.00 per hour. We are also reimbursing travel not to exceed 9464 miles at Fifty-three and 1/5 cent (\$0.535) per mile, based on the state allowable rate determined by the IRS. Total mileage reimbursement not to exceed \$5,063.24. The mileage rate is subject to change. Allowable mileage is from the contractors work site or home site, whichever route is closest.
 - Hourly rate for services is based on ECU Psychiatry Services standard charge of \$130.00 per hour.

NOTE: Travel reimbursement is at the IRS rate and is subject to change at any time. Mileage will not be included in billing or approved for payment unless the contractor comes onsite at the schools.
