2. **Is this a contract amendment? If so, please explain fully why you are amending it.** Yes. No cost, extension of time only.

3. **Why are you initiating a contract? What services will you require?**

This is a no cost extension in order to continue the work through September 30, 2017. NCDPI's Office of Early Learning has also been awarded an Enhanced Assessment Grant (EAG Award #S368A130002) to serve as the fiscal agent for a consortium of ten states. The purpose of the EAG award is to enhance the kindergarten entry assessment NC is currently developing as part of a kindergarten through third grade formative assessment process. As stipulated in the award, NCDPI's Office of Early Learning must work collaboratively with all consortium states and research partners to ensure the enhanced assessment addresses various state contexts and can be adopted for use in each of the participating consortium states at the end of the grant. In order to ensure that this enhanced assessment is developed in accordance with timelines stipulated in the grant, consistent with research related to the assessment of young children, and in a manner that adequately addresses a wide variety of state conditions, the Office of Early Learning must engage the Consortium states in activities defined in the grant to enhance NC's assessment materials and associated tools.

North Carolina's Enhanced Assessment Grant was awarded under the *Competitive Preference Priority* as an *Early Learning Collaborative Effort Among States*. Iowa is one of ten states that form the K-3 Formative Assessment Consortium. In an MOU that has been executed between and signed by North Carolina and all Consortium states, including Iowa, Consortium states agree to participate in all activities defined in the scope of work. Specifically, all states will be engaged in Tier 1 activities, which include participating in regular Consortium meetings to provide input and feedback on different stages of the assessment enhancement and conducting broad stakeholder engagement activities in their state. In addition, Iowa is one of the select states that will engage in more resource-intensive Tier 2 activities such as piloting assessment components (e.g., assessment items, report formats, technology enhancements, professional development materials) and field testing. These Tier 1 and 2 activities are detailed in the Scope of Work Guidance (Attachment A).

4. **How does the contract add value to the teaching/learning process?**

Ongoing formative assessment is necessary to understand children's strengths and needs and inform teaching and learning throughout the school year. Teachers' use of formative assessment has been shown to increase student engagement and produce significant gains in learning, particularly among low achieving students. Developing a formative assessment process that builds on information gathered at kindergarten entry and spans kindergarten through third grade can improve continuity across this early grade span and significantly impact student achievement. NCDPI's Office of Early Learning is developing a formative assessment that begins with a kindergarten entry assessment and continues through third grade in an effort to improve instructional practices of teachers and outcomes for students.

The purpose of this EAG award is to enhance the kindergarten entry assessment NC is currently developing as part of its kindergarten through third grade formative assessment. Therefore, this enhanced assessment will support the improvement of instructional practices and student outcomes in the early grades not only in North Carolina, but also in all consortium states participating in the grant.

5. **Is the service unique and not repetitive with agency activity or other contracts? Please state why this service cannot be performed within the resources of the agency.**

Because the focus of these services is on revision of NC's assessment for use in all consortium states, it is required that a number of grant-related activities be conducted within participating Consortium states. Therefore, the services provided through this contract are not repetitive with agency activities or other contracts.

6. **What is the impact, if you do not contract for these services?**

If NCDPI's Office of Early Learning does not contract for these services, its ability to meet the requirements and timelines of the grant will be significantly impaired. Without the engagement of consortium states in the enhancement process, it is unlikely that the enhanced assessment will address various state contexts and will jeopardize the K-3 Formative Assessment Consortium's ability to meet the requirement that the enhanced assessment be adopted for use in each of the participating consortium states at the end of the grant. The services that can be provided by a contract with Consortium states are critical to the success of this project.

Expenses associated with this contract will be paid from the Enhanced Assessment Grant award. NCDPI's Office of Early Learning has been awarded an Enhanced Assessment Grant (EAG Award #S368A130002) to serve as the fiscal agent for a consortium of ten states. The purpose of the EAG award is to enhance the kindergarten entry assessment NC is currently developing as part of a kindergarten through third grade formative assessment process. As stipulated in the award, NCDPI's Office of Early Learning must work collaboratively with all consortium states to ensure the enhanced assessment addresses various state contexts and can be adopted for use in each of the participating consortium states at the end of the grant as required by the award.

North Carolina's Enhanced Assessment Grant was awarded under the *Competitive Preference Priority* as an *Early Learning Collaborative Effort Among States*. An MOU executed between and signed by North Carolina and all consortium states specifies that all consortium states agree to participate in activities detailed in the scope of work to ensure the enhanced assessment addresses various state contexts and can be adopted for use in each of the participating consortium states at the end of the grant as stipulated in the award.

As specified in the grant to K-3 Formative Assessment Consortium states, up to \$25,000 is allocated to the Iowa Department of Education to conduct the following activities:

- participate in virtual and face-to-face meetings of the Consortium;
- share their state-developed early childhood and K- 3 assessment-related materials, including early learning and K-3 standards, assessment items/tasks, and professional development materials;

- participate in and provide input to the review of assessment-related materials, including standards, assessment items/tasks, the assessment as a whole, and professional development materials; and
- conduct stakeholder outreach and engagement activities to promote awareness of and support for the assessment among administrators, teachers, families, and institutions of higher education, in preparation for assessment implementation.

In addition, the grant specifies that up to \$75,000 is allocated to the Iowa Department of Education to conduct the following activities:

- provide incentives and teacher release time to participate in cognitive labs;
- provide incentives and teacher release time to participate in pilot testing;
- provide incentives and teacher release time to participate in field testing;
- convene state experts to review assessment-related materials; and
- conducting in-depth stakeholder engagement activities (e.g., focus groups with parents, teachers, administrators, and institutions of higher education staff on the assessment's design, item development, and related professional development materials).

The maximum total to be reimbursed for all grant-related activities is \$100,000 through June 2017. Iowa will invoice North Carolina at least quarterly. The Enhanced Assessment Grant Vendor Expenditure Report shall be used for invoicing and shall be accompanied by the Enhanced Assessment Grant Consortium State Activity Report detailing activities associated with expenditures on the Expenditure Report.
